### APPLICATION

Decorative and protective latex interior paint with higher degree of whiteness and opacity. For use on typical mineral substrates: lime plasters, lime-cement or gypsum plasters, plasterboards, etc., as well as surfaces covered with other paint coatings. It is designed to make decorative and protective coatings in residential and office spaces, as well as public use areas, hospitals, kindergartens, nurseries, schools, traffic routes, food industry, catering, freight forwarding and warehouse areas of the pharmaceutical industry, and other intended for human residence, wherever it is required the highest degree of aesthetic matt white. Due to good resistance to scrubbing, it is also recommended in places where highest degree of cleanliness and hygiene is required, because it allows to keep room in a neat condition. The product is available in a wide range of colors according to IMPRESSIO, TUSCANY COLOURS, COLORS OF ALASKA, COLORS OF SCANDINAVIA patterns, or to the supplied formula. It has a Hygienic Certificate issued by the National Institute of Public Health - National Institute of Hygiene.

**USE INSTRUCTION**

<b>Substrates</b>	Typical construction substrate should be clean, firm, sound, even and free of grease. Loose grain and pollution, and poorly linked to the old emulsion paint coatings must be carefully removed. Any Irregularities and defects should be supplemented with finishing filler or adequate mortar (e.g. ACRYL SPACHTEL, BUDOMONT ZT-620 or ZS-640). Surfaces infected with fungus and algae need to be disinfected with the means to remove algae and fungi by using ALGHESIL. In the case of new cement plasters there should be min. three weeks of seasoning time.																																	
<b>Priming</b>	Before applying the paint the substrate should be primed using SEMPRE GRUNT W or LATEX GRUNT, LATEX GRUNT PREMIUM. Extra-absorbent substrates need to be primed twice using the “wet on wet” method.																																	
<b>Application</b>	<p>Apply twice on a roller, brush or by spraying device, including AIRLESS spraying, keeping min. 2-hour interval. After opening the package should be noted that on the cover there is no dried paint residue resulting from improper storage. Their presence in the product may adversely affect the appearance of the coating formed. <b>Dilution</b>	The product is ready for use. If necessary, dilute with water in the amount of maximum 5%. Too much dilution can affect the durability of cover, which results in the appearance of discoloration.																																	
<b>Drying</b>	At 20°C and a relative air humidity of 55% the drying time of the coating is approx. 2 hours. Low temperatures and increased humidity extend the drying time.																																	
<b>Cleaning tools</b>	Water – directly after use.

**STORAGE**

Store the product in original, unopened container, in a cool, but frost-free place. The product is not suitable for use after freezing. Expiry date is located on the lid of the container.
