APPLICATION

Acrylic interior varnish for use on new, absorbent substrates not previously protected with coating products, including absorbent, seasoned substrates such as concrete, brick, stone, and those coated with plaster (TESORO, MARESIL, PROGRESIL, AZURO), acrylic and latex paints with a scrub resistance class of 1 or 2 according to EN-13300, and decorative products (SEMPRE PREMIO). Designed for decorative and protective coatings in residential, office, and restaurant spaces, among others. It provides environmentally friendly, easy-to-clean protection.

USE INSTRUCTION

Substrates	Typical construction substrate should be dry, clean, firm, sound, even and free of grease.
Priming	This product is intended for application over existing plaster, paint, or other decorative coatings. Primer is not required. NOTE: Before application, it is essential to test the adhesion of the INTERPROTEKT varnish to the substrate. It is essential that the existing paint coating has a wet scrub resistance of at least Class 2 according to EN 13300.
Application	Stir thoroughly before use. Apply two evenly thick coats, one at a time, over the entire surface from edge to edge to avoid dry cuts. Applying the product with a brush may result in varying degrees of transparency. It is recommended to work at temperatures between +5 and +30°C.
Dilution	The product is ready for use, does not require dilution.
Drying	At 20°C and a relative air humidity of 55% the drying time of the coating is approx. 2 hours. Low temperatures and increased humidity extend the drying time.
Cleaning tools	Water – directly after use.

PACKING

STORAGE

Store the product in original, unopened container, in a cool, but frost-free place. The product is not suitable for use after freezing. Expiry date is located on the lid of the container.

Keep out of reach of children. Non-inflammable. It is not classified as dangerous under current law. While working maintain basic health and safety rules.
